BILL**

*further to amend the laws relating to the Salaries and Allowances of the Members of the Provincial Assembly of the Province of the Khyber Pakhtunkhwa and Salaries, Allowances and Privileges of the Speaker and Deputy Speaker of the Province of the Khyber Pakhtunkhwa.*

WHEREAS it is expedient further to amend the Provincial Assembly of the Khyber Pakhtunkhwa Province (Salaries and Allowances of Members) Act, 1974 (Khyber Pakhtunkhwa Act No. XI of 1974) and the Khyber Pakhtunkhwa Province Speaker and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975 (Khyber Pakhtunkhwa Act No. III of 1975), for the purposes hereinafter appearing;

It is hereby enacted as follows:

**1. Short title and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa Salaries, Allowances and Privileges Laws (Amendment) Act, 2017.

(2) It shall come into force at once. *and shall be deemed to have taken effect from 1st July 2016.*

**2. Amendment of certain laws.**---The laws specified in column No. 3 of the Schedule append to this Act shall be amended to the extent and in the manner specified against each in column No. 4 of the said Schedule. *Parag mian*
